1 Benefits

Benefits of using the Advance Warehouse:

- Advance tracking of your show freight
- Shipments are planned to be delivered by 10:00 am on your assigned target date
- Eliminate truck line waiting charges
- Inspection of your show freight if necessary, warehouse is approximately 11 miles from McCormick Place
- Exhibitors will be notified to find out when their freight arrives at the warehouse.

2 Guidelines

Guidelines for Warehouse Shipments

- No full truckloads (T/L's) to come through the warehouse
- No shipments over 7000 lbs. and individual pieces over 10' in length, total shipment not to exceed 20' in length
- The maximum height is 96 inches or 8 feet
- The maximum weight is 5,000 lbs. per piece
- No uncrated or pad wrapped machinery or shipments
- No flatbeds or ground deliveries
- No loose or unwrapped carpet. Includes full loads where we have to sort and segregate.

The Advance Warehouse will accept freight from Monday, September 19, 2022 through Friday, October 7, 2022.

Any refrigerated storage required must be ordered prior to September 7, 2022. Requests received after September 7, 2022, cannot be accommodated. Please contact PES at pack.expo@packexposervices.com for refrigerated/frozen storage pricing.
